Timor Plaza, Dili, Timor Leste

Thursday 10 July 2014 to Saturday 12 July 2014

The programme will be in two parts: the main programme and, running parallel with the main programme for some but not all of the conference, a programme directed specifically towards the continuing professional development (**CPD**) requirements for Territory practitioners.

#### **General Programme**

The general programme will be opened on Thursday morning, 10 July 2014, by <u>Dr Dionisio Babo-Soares</u>, Minister of Justice, Timor Leste. Dr Babo-Soares will be followed by <u>Professor Hilary Charlesworth</u> who will deliver the key note address. Professor Charlesworth is one of Australia's most highly regarded experts in public international law and human rights, including democratic development post conflict. She has also maintained a very close interest in Timor Leste, being one of the authors of *Networked Governance of Freedom and Tyranny: Peace in Timor-Leste*, published in 2012.

The balance of the first day will focus on the tension between indigenous legal systems and Christian-based western legal systems both in theory and in the practical way the systems of justice in Timor Leste and the Northern Territory attempt to deal with domestic violence and child welfare. Speakers include:

- <u>Luis de Olivera Sampaio</u>, Director, Judicial System Monitoring Programme, Timor-Leste;
- Dr Susan Harris Rimmer, Director of the Asia -Pacific College of Diplomacy at ANU;
- Justices Judith Kelly and Jenny Blokland, NT Supreme Court;
- <u>Danial Kelly</u>, senior lecturer in law at Charles Darwin University including in indigenous legal issues;
- <u>Jeswynn Yogaratnam</u> law academic at Charles Darwin University and its principal lecturer in Human Rights Law (by video);
- <u>Gabby Brown</u> (Solicitor for the NT), <u>Jaquie Palavra</u> (NTLAC) and <u>James Stoller</u> (NAAJA), senior Territory child welfare practitioners
- <u>Dr Jose Cornelio Guterres</u>, Anthropologist and Sociologist and the Director of the Masters Program at Universidade da Paz, Dili

Thursday's sessions will finish in the early evening with a short presentation by <u>Felicity Gerry QC</u>, a barrister from the UK and a lecturer at the Charles Darwin University, on the duties of defence lawyers in relation to the victims of people trafficking followed by the Timor Leste premiere of '<u>Not My Life'</u>, a ground-breaking film which exposes the cruel and dehumanizing practices of human trafficking and modern slavery on a global scale.

Friday will focus on issues in relation to resources including in the Timor Gap, boundary issues in the Gap, an update on the current arbitration and ICJ proceedings between Australia and Timor Leste and related legal topics.

## Speakers include:

- Bernard Collaery former ACT Attorney-General, lawyer representing Timor Leste in the current arbitration against Australia and whose legal office in Canberra was raided recently by the Australian authorities;
- <u>Ricardo Silva</u>, Deputy Head of Energy Practice of the international law firm, Miranda Correia Amendoeira & Associados, and the partner responsible for its Timor-Leste Practice:
- <u>Dr Christopher Ward</u>, barrister and co-author of the Lowe, Carleton & Ward 'Petro Timor Opinion' on the extent of East Timor's maritime boundaries;
- Ros Vickers, environmental law specialist and lecturer in law at Charles Darwin University (by video);
- John Randall QC, senior UK commercial silk and adjunct professor at the University of NSW:
- <u>Greg Phelps</u>, lawyer representing the victims in and around Timor of the Montara Oil Spill
- Dr David Price, Associate Professor, School of Law, Charles Darwin University
- Salvador Soares, Masters Student, School of Law, Charles Darwin University.

Saturday morning will focus on institutional development and the rule of law with particular reference to Timor Leste. Speakers will include:

- <u>Dr Brett Williams</u>, Solicitor and Barrister (NSW), Brett G Williams Law Office, specialist in International Regulation of Trade, speaking on "Integrating Timor-Leste into the ASEAN Economic Community and the World Trading System";
- Christoph Sperfeldt, a PhD Scholar at the Centre for International Governance and Justice, Australian National University, and who has worked as Regional Program Coordinator at the Asian International Justice Initiative, speaking on "Judicial Education and ASEAN Integration: A Comparative Overview and Challenges and Opportunities for Timor Leste"
- Duncan McConnel, president elect Law Council of Australia.

Saturday afternoon will be a "where to from here?" session.

### **NT Practitioners Programme**

Sessions will be conducted in parallel with some of the general programme focusing on:

Current ethical issues for advocates (core competency (a)) - 1 hour workshop led by Mark Thomas, with additional commentary from other senior practitioners.

The marketing of professional services in the 21<sup>st</sup> Century (core competency (b)) - 1 hour workshop led by Felicity Gerry QC (UK), with additional commentary from John Randall QC (UK).

Effective Advocacy in Mediations (core competency (c)) - 1 hour workshop led by Alistair Wyvill SC.

Compensation for Workers in the Territory – where to from here? - 1 hour workshop led by Ben O'Loughlin, Peggy Cheong and George Roussos.

Civil Procedure Update – Pre-action discovery and Privilege - 1 hour workshop led by Tom Anderson and Les McCrimmon.

<u>Legal practitioners are eligible to claim at least 10 CPD points for attendance at this conference. All required CPD competencies for Northern Territory legal practitioners are being covered during the conference.</u>

### **Social Programme**

There will be a welcoming cocktail party commencing at the Timor Plaza from 6:00pm on Wednesday 9 July 2014 in the roof garden of the Timor Plaza.

The conference dinner will be held at the Timor Plaza on the evening of Saturday 12 July 2014. The speaker will be Mr Jon Tippett QC of the NT Bar and who also practices regularly as an advocate in Timor Leste.

Informal events are being arranged for the other evenings of the conference. A series of events will also be arranged during the day for those who are registered as accompanying delegates if they are interested. The cost of these events will be at your own cost and charged separately.

#### **Accommodation**

The NTBA has reserved all accommodation at the <u>Timor Plaza</u> from Wednesday 9 July until Sunday 13 July 2014. ### **Flights**

The first flight departs at 5.45am and arrives in Dili at 6.30am. The second flight departs Darwin at 4.00pm and arrives in Dili at 4.45pm.
